The approval for the expansion of Raven Substation was granted by two agencies:

1. **Florida Department of Environmental Protection-** attached is the modification to permit # 296190-004-EM. I had no correspondence with FDEP concerning the approval of the project.
2. **Columbia County, Florida-** attached is the approval letter and corresponding Resolution # BA SE 0617 for the Special Exception granting the expansion. This approval for expansion covered all site-related activities so there were no additional building permits as it was all inclusive in the Special Exception.
