Subject: COMPLAINT: \$25/month minimum base electric bill

Dear Commissioners,

I want to **strongly** voice a complaint regarding the subject minimum \$25/month minimum base bill that you approved and which first appeared on my FPL bill this month.

As a homeowner, I previously made a decision to invest in clean energy technology and installed solar panels at my residence which would offset my high electric bills from Florida Power & Light.

As a result of your actions, I have now started paying FPL \$29.92 per month for ZERO electricity consumed! As you can verify from my most recent billing (attached), last year my monthly bill was \$9.96 which later increased to \$10.76 per month, and this month nearly TRIPLED to \$29.92.

Although your approval of a \$25/month minimum base bill for electricity might not have considered situations like my own where I am now paying FPL each month for NO ENERGY DELIVERED, it has nevertheless had an unexpected and undesired impact on me.

I consider this recent change to be GROSSLY UNFAIR, and simply a MONEY GRAB by FPL for charging me this amount each month when their net energy delivery to my home is ZERO.

What actions will you be taking to rectify this situation you have created? I am being now being penalized financially for my investment in clean energy technology. This cost penalty also applies to every other Florida homeowner who has installed solar or some other clean energy technology solution.
