6 Item 5 addresses Florida City Gas proposed
7 rate increase. On May 31st of this year FCG filed
8 its petition requesting a permanent rate increase
9 of approximately 29 million.

10 Staff recommends that the Commission suspend
11 FCG's proposed rate scheduled to allow staff and
12 intervenors sufficient time to address the petition
13 and to determine whether the requested rate
14 increase is appropriate.

15 The company did not request interim rates, and
16 the hearing for this case is currently scheduled
17 for December 12th through the 16th.

18 Staff is available for questions.
