In regards to recent rate hike requests scheduled for hearing in March: Please do not approve these rate hikes proposed by FPL. 'Turning now to our financial performance, NextEra Energy delivered strong third quarter results, with adjusted earnings per share increasing by approximately 13% year-over-year,' a third quarter earnings call said. A fourth quarter earnings

report is expected Wednesday. From Oct. 20, 2022 to date, NextEra Energy's stock price has gone up \$11.79 per share, though with some minor fluctuations."
