Good Afternoon,

My name is Reid Kirkland with the Florida Public Service Commission. This Email is a follow-up to our phone conversation from earlier today regarding the 2022 Regulatory Assessment Fee (RAF) return and payment for Tone Communications Services LLC (TY178). As we discussed, the Regulatory Assessment Fee (RAF) return form and payment for Tone Communications Services LLC (TY178) has not yet been received by the Commission. The due date for this filing was 01/30/2023, US Postmark, and the account is now delinquent.

In accordance with our conversation from this morning, I have attached a copy of the 2022 RAF Return Form as well as the delinquent notice to this email. Filing instructions for filling out the RAF return form and making the payment are included on the second page of the attached electronic copy of the RAF Return Form.

As detailed on the second page of the RAF Return Form (attached) as well as Rule 25-4.0161, Florida Administrative Code (F.A.C.),

• Failure to file a return by the established due date will result in a penalty being added to the amount of the fee due, 5% for each 30 days or fraction thereof, not to exceed a total penalty of 25%. In addition, interest shall be added in the amount of 1% for each 30 days or fraction thereof, not to exceed a total of 12% per year.

Accordingly, since the RAF payment of \$600.00 was not received postmarked on or before the due date of 01/30/2023, and also not before March 1, 2023, two rounds of a late penalties and interest have accrued on the RAF amount due, bringing the total amount owed to \$672.00 (600.00 RAF due + (.05 late penalty X 2 X 600.00) + (.01 interest X 2 X 600.00) = \$672.00). We kindly request that you submit payment by mail to our agency as soon as possible to resolve this matter and avoid additional penalties and interest.

Also, Since you have reached out to our office of Industry Development and Market Analysis (IDM) regarding voluntary cancellation of your certificate (8943), Rule 25-4.0161, F.A.C. and Section 364.336, Florida Statutes, state in part "if a company has an active certificate for any portion of the RAF billing cycle, they will owe at least the minimum RAF's for that billing cycle." The minimum RAF is \$600 for CLX service providers. Since Tone Communication Services (TY178) presently has an active certificate for this portion of 2023, the Company will also be responsible for paying 2023 RAFs. I have attached a copy of the 2023 RAF form to this email as well.
