2	CHAIRMAN FAY: All right. Ms. Watts, next you
3	want to present Items 4, 5 and 6, and just a quick
4	summary of why they are presented together?
5	MS. WATTS: Commissioners, Items 4, 5 and 6
6	are staff's recommendation transfer of facilities
7	and certificates from BFF Corp, C.F.A.T. H2O, Inc.,
8	and Tradewinds Utilities, Inc., in Marion County to
9	CSWR Florida Utility Operating Company, LLC.
10	BFF serves approximately 108 wastewater
11	customers. C.F.A.T. serves approximately 239 water
12	and 248 wastewater customers. And Tradewinds
13	serves approximately 505 water and 279 wastewater
14	customers.
15	As mentioned previously, the utilities are
16	owned by the same person. CSWR has negotiated a
17	single purchase agreement with the owner for the
18	three utilities, but will not close on the sale
19	until it has received Commission approval for the
20	transfers.
21	In conjunction with each transfer request,
22	CSWR is also requesting a positive acquisition
23	adjustment.
24	Staff recommends the Commission approve the
25	amendments to the C.F.A.T. and Tradewinds service

1	territories, and the transfers of the facilities
2	and certificates of BFF, C.F.A.T. and Tradewinds
3	effective the date that the sale becomes final.
4	Staff also recommends the Commission deny the
5	request for positive acquisition adjustments as
6	CSWR did not demonstrate extraordinary
7	circumstances.
8	And again, representatives of CSWR and the
9	Office of Public Counsel are available for
10	questions, as is staff.
11	COMMISSIONER GRAHAM: Great. Thank you, Ms.
12	Watts.
13	All right. Commissioners, you have a summary
14	on Items 4, 5 and 6. Any comments or questions on
15	those items?
