(PGSI) requests confidential classification of certain highlighted information contained in response to the Office of Public Counsel's 1<sup>st</sup> request for production of documents, No. 16, and interrogatories 100, 244, and 245, in Document No. 04869-2023. More specifically, the information for which confidentiality is sought relates to prospectuses for Peoples Gas System, Tampa Electric Company, and Emera, Incorporated, short-term debt, and the five primary causes for rate increase.
