**ST. JOE NATURAL GAS COMPANY'S PRELIMINARY
LIST OF ISSUES AND POSITIONS**

St. Joe Natural Gas Company, Inc. ("SJNG") by and through its undersigned officer, hereby submits its Preliminary List of Issues and Positions to be taken up at the Hearing now scheduled to begin **November 1, 2023** in the above listed docket.

Issue 1: What are the final conservation cost recovery adjustment true-up amounts for the period January through December 2022?

SJNG's Position: \$6,053 over-recovery.

Issue 2: What are the appropriate conservation adjustment actual/estimated true-up amount for the period January through December 2023?

SJNG's Position: \$ 19,101 over-recovery

Issue 3: What are the appropriate total conservation adjustment true-up amount to be collected/refunded from January 2024 through December 2024?

SJNG'S Position: \$25,154 over-recovery

Issue 4: What is the total conservation cost recovery amounts to be collected during the period January 2024 through December 2024?

SJNG's Position: An Under-recovery of \$141,596.

Issue 5: What are the conservation cost recovery factors for the period January 2024 through December 2024?

SJNG's Position: \$0.33922 per therm for RS-1, \$0.24049 per therm for RS-2, \$.18160 per therm for RS-3, \$.10751 per therm for GS-1, \$.06358 per therm for GS-2, and \$.03877 per therm for FTS-4.

Issue 6: Should the Commission approve revised tariffs reflecting the natural gas conservation cost recovery amounts and establishing natural gas conservation cost recovery factors determined to be appropriate in this proceeding?

SJNG's Position: Yes

Issue 7: What should be the effective date of the new conservation cost recovery factors for billing purposes?

SJNG'S Position: The effective date should be January 1, 2024.

Issue 8: Should this docket be closed?

SJNG'S Position: Yes sir
