

PUBLIC SERVICE COMMISSION
FAR NOTICE OF SECURITIES APPLICATION

The Florida Public Service Commission will consider at its October 3, 2023, Agenda Conference, Docket No. 20230088-EI – the application of Florida Power & Light Company (FPL) and Florida City Gas (FCG) for authority to issue and sell securities pursuant to Section 366.04, Florida Statutes, and Chapter 25-8, Florida Administrative Code. FPL seeks Commission approval to (a) authorize FPL to issue and sell and/or exchange any combination of long-term debt and equity securities and/or to assume liabilities or obligations as guarantor, endorser or surety in an aggregate amount not to exceed \$8.5 billion during calendar year 2024; (b) authorize FPL to issue and sell short-term securities in an amount or amounts such that the aggregate principal amount of short-term securities outstanding at the time of and including any such sale shall not exceed \$5.5 billion during calendar years 2024 and 2025; (c) authorize FCG to make long-term borrowings from FPL in an aggregate principal amount not to exceed \$300 million during calendar year 2024; and (cl) authorize FCG to make short-term borrowings from FPL in an aggregate principal amount not to exceed \$ 150 million at any one time during calendar years 2024 and 2025.

DATE AND TIME: Tuesday, October 3, 2023. The Agenda Conference begins at 9:30 a.m., although the time at which this item will be heard cannot be determined at this time.

PLACE: Commission Hearing Room 148, Betty Easley Conference Center, 4075 Esplanade Way, Tallahassee, Florida 32301.

PURPOSE: To take final action in Docket No.20230088-EI - Application for authority to issue and sell securities during calendar years 2024 and 2025, pursuant to Section 366.04, F.S., and Chapter 25-8, F.A.C., by Florida Power & Light Company and Florida City Gas.
