6	Shannon Hudson on behalf of Commission staff.
7	Item No. 4 is staff's recommendation
8	addressing Florida Community Water Systems' request
9	for a revenue rate restructuring to consolidate its
10	rates of its 10 water systems and four wastewater
11	systems. In addition, the recommendation addresses
12	the disposition of overearnings.
13	Staff recommends that the Florida Community
14	Water Systems' rates be consolidated. Staff
15	believes the consolidation will provide economies
16	of scale, promote cost savings associated with
17	regulatory filings, provide rate stability across
18	all systems, and address the high usage of the
19	harbor water system.
20	In addition, staff recommends the utility's
21	proposed refund to dispose of overearnings be
22	approved.
23	There has been one customer contact following
24	the customer meeting. The utility's representative
25	Tory Rendell is available by phone to address the

1	Commission.
