25	certain state laws with respect to independent

1	special districts such as the port.
2	Staff recommends that the Commission approve
3	the special contract between Peoples and Tampa Port
4	Authority. Peoples should file a conformed copy of
5	the signed special contract with the Commission
6	before the special contract becomes effective.
7	CHAIRMAN FAY: Great. Thank you, Mr. Ward.
