I am a recently retired older person living in Hillsborough County on a fixed income who is confronted with the conflicting needs of being able to properly cool and heat my apartment to near-comfortable (health/well-being) and my being able to afford that. I've become aware of the TECO petition to file only a 4CP with an MDS rather than a 12CP and 1/13th cost of service study. I understand this will shift TECO's rate increases to residential customers rather than being shared by commercial/industrial customers - the heaviest users of electricity. Residential customers cannot afford to take on the additional cost of subsidizing TECO's industrial and commercial customers - TECO's heaviest users of electricity.

In Tampa, during this past August's 31 days alone, 29 of those days were 90-96 (F) degrees. July had 16 such days.
