Dear Florida Public Service Commissioners,

I am writing to urgently bring to your attention the ongoing concerns of residents in Wedgefield, Orange County, regarding the rates and services provided by Pluris Wedgefield, LLC, the water and wastewater company. Tomorrow, April 2nd, you are scheduled to discuss and listen to the residents' concerns, and I urge you to carefully reconsider the charges for the service they provide.

As the Orange County Commissioner representing Wedgefield, I have been actively engaged in addressing the persistent challenges faced by our residents. These challenges include issues related to water quality and the high rates imposed by Pluris Wedgefield, LLC. Many residents

have expressed their difficulties in affording the steep rates, which currently amount to \$166.62 per 5,000 gallons, compared to Orange County Utilities' rate of \$68.07 for the same service.

In addition to the rate disparities, there are concerns about the condition of Pluris Wedgefield's infrastructure, including reports of rusting pipes and deferred maintenance. Orange County Utilities has identified these issues during its assessment of the system, raising further concerns about the justification for the rate increases imposed previously and currently by Pluris Wedgefield, LLC.

Recognizing the urgency of the situation, I have continued to support the residents' interest in acquiring Pluris Wedgefield by Orange County. This acquisition project is currently progressing through Phase III, which involves assessing the value and condition of the system through an appraisal process. However, in the interim, it is crucial that immediate steps are taken to address the residents' concerns about the high rates and service quality.

I urge you to carefully consider the plight of Wedgefield residents and take proactive measures to revise the charges imposed by Pluris Wedgefield, LLC. Lowering the water and wastewater monthly rates would provide much-needed relief to our residents who are already facing challenges due to increases in the cost of living.

Thank you for your attention to this important matter. I look forward to your swift action in addressing the concerns raised by Wedgefield residents regarding Pluris Wedgefield, LLC.
