Request for Confidential Classification for Document No. 01366-2024.

On March 28, 2024, Peninsula Pipeline Company, Inc. (Peninsula or Company) filed a request for confidential classification for Document No. 01366-2024. This document consists of Exhibit A to the natural gas firm transportation agreement included as Attachment A to the petition (Document No. 01362-2024). The document contains certain information identifying the total maximum daily transportation quantity, maximum hourly transportation percentage, and a monthly reservation charge. Peninsula states that both the Company and Florida Public Utilities Company treat the highlighted information provided in Document No. 01366-2024 as confidential. Staff reviewed the document and concurs with Peninsula that the nature of the information meets the requirements set forth in Sections 366.093(3)(d) and (e), Florida Statutes, whereby disclosure of the information would harm the competitive business operations of Peninsula. Therefore, staff recommends that the request by Peninsula for confidential classification of Document No. 01366-2024 be approved.
