This is deemed to not be an improvement over the current septic system our family has well maintained over the life of our property. Not an improvement environmentally or with regard to functionality. When I flush my toilet, *all product* should exit my property (and the island) and go to a central system processing affluent plant. Not hold on another tank on my property.

The initial cost estimates presented with the system are poorly defined, leaving us owners open to costs increases as the system developer incurs them. This is not operating in the sunshine, as the state of Florida is compelled to operate. The initial cost estimates, as presented, both upfront and for ongoing service charges - are too much for my family to bear. This is highlighted as we struggle to carry inflated costs for property insurances (flood, windstorm, and homeowners), increasing Charlotte County property taxes, and our ever increasing private water supply utility service charges. This is also on top of the FACT that we are still rebuilding our property after destruction from Hurricane Ian!

The experience and ability of Environmental Utilities, LLC is questionable. The barrier island community is a harsh and unhospitable environment for utilities. Power (FPL), phone/internet service are constantly going "down" on the island with major companies sending teams in for repair of services. Environmental Utilities is

not a major operator with solid infrastructure support behind them. Repairing a sewer line in a fragile coastal ecosystem is of paramount importance. No real mention of how this system is to be serviced/backstopped.



Commissioner LaRosa,

After reviewing the Environmental Utilities, LLC proposal for sewerage on Palm Island, I'm persuaded that this private utility company is enterprising an opportunity for its own enrichment rather than addressing an actual need, which does not, in fact, exist. Palm Island neither has nor foresees a problem with sewerage, and no proven reason has been provided for why we need it. The scope of the proposed project is extensive and would incur considerable private property and traffic flow disruption on our tiny, bridgeless barrier island, without providing any genuinely necessary service.

That said, were we to need sewerage, this should be handled by the county, not a private (in this case inexperienced and unqualified) enterprise, and we should be taxed accordingly.

Therefore on behalf of our island community, I ask that this egregiously inappropriate application by Environmental Utilities, LLC, be turned down.
