The new system was not requested by the homeowners. I am also not comfortable with the rates and charges associated with this project.

The island does not need to be disrupted at this point. We just finished rebuilding since the hurricane and the roads have just been restored nicely. This was done with a lot of work and money.

Also, the animals are also still recovering, including eagles trying to nest.

Finally, this is the worst time to put extra cost on homeowners immediately after the hurricane rebuild. Property taxes and property insurance increases are already straining home owners.
