**THE FLORIDA RETAIL FEDERATION’S NOTICE OF JOINDER
IN CITIZENS’ MOTION FOR RECONSIDERATION OR, IN THE
ALTERNATIVE, MOTION FOR CONTINUANCE**

The Florida Retail Federation (“FRF”), by and through undersigned counsel and pursuant to Rule 25-22.0376, Florida Administrative Code (“F.A.C.”), hereby joins in the Expedited Motion for Reconsideration filed in these proceedings by the Citizens of the State of Florida (“Citizens”) of Order No. PSC-2024-0092-PCO-EI, issued on April 11, 2024 (the “DEF Order”) and of Order No. PSC-2024-0096-PCO-EI, issued on April 16, 2024 (the “TECO Order”), and in the Citizens’ requested alternative relief of a continuance of these proceedings. The FRF also joins in the Citizens’ Request for Expedited Oral Argument on the Citizens’ Motion for Reconsideration.

The FRF has been granted intervention in Docket No. 20240026-EI, the Tampa Electric rate case, and related dockets by Order No. PSC-2024-0124-PCO-EI, issued on April 23, 2024, and has filed a motion to intervene in Docket No. 2024-0025-EI, the Duke Energy Florida rate case, which is pending. As a party in

all of the dockets relating to Tampa Electric's rate increase request and as a prospective intervenor in Duke Energy Florida's 2024 case, the FRF and its members have substantial interests in having the Commission grant the relief requested by the Citizens' Motion for Reconsideration.

WHEREFORE, in the public interest of having the pending rate increase requests fully reviewed and tested by all parties to these dockets, and in the interests of the FRF and its members who are customers of Tampa Electric and Duke Energy Florida, the FRF joins in the Citizens' Motion for Reconsideration or Alternative Motion for Continuance and prays that the Commission will grant that Motion.
