This report was prepared in accordance with the Decommissioning Services Agreement (DSA) between Duke Energy Florida (DEF), LLC and Accelerated Decommissioning Partners (ADP), LLC. After approval, this report will be provided to the Florida Public Service Commission as directed by order number PSC-2020-0289-FOF-EI.

Executive Summary:

ADP worked safely in 2023 with 1 OSHA recordable accident, no used fuel storage or security incidents and no environmental events. No reports were made by the Nuclear Regulatory Commission (NRC).

A. Summary of events, defined in attachment 9 section A, ADP made to DEF in 2023

There were no events requiring notification by ADP to DEF.

B. Summary of the quarterly information ADP provided to DEF by ADP in 2023

The quarterly reports and face-to-face meetings between ADP and DEF highlighted the following:

- ADP had no used fuel storage or security related issues in 2023.
- ADP had 1 OSHA recordable injury. The recordable case was a subcontractor pinched finger working to replace a blade for the Ride-On tile removal machine. ADP safety focus shifted to emphasizing stop work and recognition of employees having the ability to stop work in the face of uncertainty. Fire prevention, heat stress management and other more jobspecific topics remain a part of the overall safety topics.
- Both parties complied with all the requirements, including deliverables, in the DSA.
- There were no pay disputes in 2023.
- There were no issues that were elevated to levels of management beyond those leaders at the site for resolution.
- ADP provided quarterly schedule updates and regulatory related activities to DEF during the year.

There were two areas of performance that were discussed in the quarterly meetings.

• The first was the Personnel Contamination Events (PCE).

In response to these events, ADP continues to address PCE to shoes by changing outer rubber to heavy boots and using different material from paper for inner covers. The PCE to shoes will continue to be monitored throughout 2024 to determine if actions are effective.

• The second area of performance discussed was related to Safety Conscious Work Environment (SCWE). ADP indicated that the NRC continues to monitor corrective action effectiveness with no additional requirements.

C. Summary of Schedule Performance

- On January 1, 2023, the decommissioning project was 49.3% complete with a baseline target completion of 46.32%.
- On December 31, 2023, the decommissioning project was 64.25% complete with a baseline target completion of 64.19%. ADP met baseline schedule at the end of 2023.
- The decommissioning project baseline target for December 31, 2024, is 81.81%.
- ADP estimates that Milestone 1 conditions will be met in 4th quarter 2026.

D. Summary of Cost Performance

- ADP submitted twelve monthly invoices in 2023 totaling \$80,694,880.
- DEF owner's cost in 2023 was \$1,395,021.
- During calendar year 2023, \$1,619,555 was disbursed from the Nuclear Decommissioning Fund (NDF) for DEF costs and \$75,860,835 for ADP payments for a total of \$77,480,390.
- The NDF balance on December 31,2023 was \$364,695,116 not including the non-qualified portion of the fund.
- The NDF withdrawals were for DEF costs and ADP payments from the December 2022 invoice through the October 2023 invoice due to the timing of the invoice payment process and the NDF reimbursement process.
- It is estimated that ADP will invoice DEF \$95,143,149 for calendar year 2024 and DEF owner costs are estimated to be \$1.6M. It is estimated that \$94,145,829 will be disbursed from the NDF in 2024.
