In December with my bill I received the news that effective in January of 2024 the typical residential customer's monthly energy bill will decrease by about 11%. Commercial and Industrial customers were to see a decrease of between 10 - 18% depending on usage. Tampa Electric bills will be below the national average and among the lowest in Florida it said. Along with that the May bill due in June said there was an approval for a fuel cost reduction beginning in June 2024 due to lower natural gas prices which would allow the typical residential customer to see an additional decrease of 5% and the average commercial and industrial customer's monthly bill will decrease between 4 -11% depending on usuage. Now along with that information for June 2024 is another letter that talks about a request for rate increases after having rate decreases for 5 months and another 5% decrease in June was approved now you want to raise rates.
