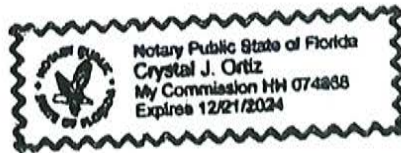

By Order No. PSC-2024-0127-PAA-WS, issued April 23, 2024, in Docket No. 20230114-WS, the Florida Public Service Commission (Commission) approved an application for certificates to provide water and wastewater service in Volusia County, by Applegate Utility, LLC. The rates shall be effective for service rendered as of the Commission's stamped approval date on the tariff sheets provided the customers have received notice. If the effective date of the new rates falls within a regular billing cycle, the initial bills at the new rate may be prorated. The old rates shall be prorated based on the number of days in the billing cycle before the effective date of the new rates. The new rate shall be prorated based on the number of days in the building cycle on and after the effective date of the new rates. For charges, the effective date shall be for service rendered or connections made on or after the Commission's stamped approval date on the tariff provided customers have received notice.
