Request For Confidential Classification for Document No. 06922-2024

On June 25, 2024, Peoples Gas System, Inc. (Peoples) filed a request for confidential classification of Document No. 06922-2024. This document contains certain information in Exhibit C to the confidential document with Florida Public Utilities Company (FPUC) for the confidential document on page 2. Specifically, Peoples identified the reservation charge and usage charge on page 4 of 9. They also identified the maximum transportation quantity and meter at interconnect usage on page 9 of 9. Furthermore, Peoples explained in its request for confidential classification that both Peoples and FPUC treat the information as proprietary confidential business information that is not otherwise available in the public domain.

Staff reviewed the document and concurs with Peoples that the nature of the information meets the requirements set forth in Sections 366.093(3)(d) and (e), Florida Statutes, whereby disclosure of the information would harm the competitive business operations of Peoples. Therefore, Staff recommends that the request by Peninsula for confidential classification of Document No. 00968-2024 be approved
