DUKE ENERGY FLORIDA LLC'S FIRST REQUEST FOR EXTENSION OF CONFIDENTIAL CLASSIFICATION

Duke Energy Florida, LLC, ("DEF" or "Company"), pursuant to Section 366.093, Florida Statutes (F.S.), and Rule 25-22.006, Florida Administrative Code (F.A.C.), submits this First Request for Extension of Confidential Classification for certain information contained in Staff's Audit Workpapers pertaining to DEF's 2022 Financial Audit (*Audit Control No. 2022-003-1-4 and Audit Control No. 2022-003-1-5*). In support of this Request, DEF states:

- 1. On May 9, 2022, DEF filed its Request for Confidential Classification (document number 02876-2022t) for certain information contained in the Staff audit work papers as it contains "proprietary business information" under Section 366.093(3), Florida Statutes.
- 2. DEF's May 9, 2022, Request was granted by Order No. PSC- 2023-0015-CFO-EI on January 5, 2023. The period of confidential treatment granted by that order will expire on July 5, 2024. The information continues to warrant treatment as "proprietary confidential business information within the meaning of Section 366.093(3), F.S. Accordingly, DEF is filing its First Request for Extension of Confidential Classification.
- 3. DEF submits that the confidential information contained in the Order issued on January 5, 2023, identified in Exhibit "A" and Exhibit "C" to the May 9, 2022, Request continues

F.S. and continue to require confidential classification. See Affidavit of Gary P. Dean at ¶ 6,

to be "proprietary confidential business information" within the meaning of section 366.093(3),

attached as Revised Exhibit "D". This information is intended to be and is treated as confidential

by the Company. The information has not been disclosed to the public. Pursuant to section

366.093(1), F.S., such materials are entitled to confidential treatment and are exempt from the

disclosure provisions of the Public Records Act. See Affidavit of Gary P. Dean ¶¶ 4-6.

4. Nothing has changed since the issuance of Order No. PSC-2023-0015-CFO-EI to

render the information stale or public such that continued confidential treatment would not be

appropriate. Upon a finding by the Commission that this information continues to be "proprietary

confidential business information," it should continue to be treated as such for an additional period

of at least 18 months and should be returned to DEF as soon as the information is no longer

necessary for the Commission to conduct its business. See §366.093(4), F.S.

5. WHEREFORE, for the foregoing reasons, DEF respectfully requests that this First

Request for Extension of Confidential Classification be granted

AFFIDAVIT OF GARY DEAN IN SUPPORT OF DUKE ENERGY FLORIDA, LLC'S FIRST REQUEST FOR EXTENSION OF CONFIDENTIAL CLASSIFICATION

BEFORE ME, the undersigned authority duly authorized to administer oaths, personally appeared Gary Dean, who being first duly sworn, on oath deposes and says that:

- 1. My name is Gary Dean. I am over the age of 18 years old, and I have been authorized by Duke Energy Florida (hereinafter "DEF" or the "Company") to give this affidavit in the above-styled proceeding on DEF's behalf and in support of DEF's Request for Confidential Classification (the "Request"). The facts attested to in my affidavit are based upon my personal knowledge.
- 2. I am the Rates and Regulatory Strategy Manager within the Regulatory Planning Projects department. This department is responsible for regulatory planning and cost recovery for DEF.
- 3. As the Rates and Regulatory Strategy Manager, I am responsible, along with the other members of the section, for the production and review of the regulatory

financial reports of DEF and analysis of state, federal and local regulations, and their impact on DEF.

- 4. DEF is seeking an extension of confidential classification for a portion of Staff's Audit Workpapers (*Audit Control No. 2022-003-1-4 and Audit Control No. 2022-003-1-5*), filed in docket number 20220001-EI. There are no changes to the information contained in DEF's confidential Exhibit A, redacted Exhibit B, and justification matrix C. The referenced Exhibits are on file with the Clerk. DEF is requesting an extension of confidential classification of this information because it contains sensitive business information, the disclosure of which would impair the Company's competitive business interests.
- 5. The confidential information at issue is confidential proprietary information. The Staff Audit Workpapers contain confidential information of both DEF and third-party companies, the disclosure of which would impair the Company's competitive business interests and efforts to contract for goods or services on favorable terms. DEF has not publicly disclosed the information. Without DEF's measures to maintain the confidentiality of this sensitive business information, DEF's ability to contract with third parties could detrimentally impact DEF's ability to negotiate favorable contracts, thereby harming its competitive interests, ultimately to its customers' detriment.
- 6. Upon receipt of confidential information from capacity suppliers, and with its own confidential information, strict procedures are established and followed to maintain the confidentiality of the terms of the documents and information provided, including restricting access to those persons who need the information to assist the

Company, and restricting the number of, and access to the information and contracts. At no time since receiving the contracts and information in question has the Company publicly disclosed that information or contracts. The Company has treated and continues to treat the information and contracts at issue as confidential.

7. This concludes my affidavit.
