DEF's response to POD No. 23 consists of sensitive project documents, including pricing information for goods and service, related to a construction project at a generating facility. DEF asserts that the data is proprietary, and public disclosure would impair it in the marketplace.

Staff has reviewed DEF's confidentiality request and agrees that the nature of the information meets the requirements set forth in Section 366.093(3)(d), F.S. Therefore, staff recommends that the request for confidentiality of certain information included in Document No. 03939-2024 be approved.
