Pursuant to Section 366.093(3)(e), Florida Statutes (F.S.) and Rule 25-22.006, Florida Administrative Code, Duke Energy Florida, LLC ("DEF") requests confidential classification of certain information provided in response to FIPUG's 1st request for PODs (Nos. 1-21); specifically, response to POD No. 21. The document number for the confidential filing is 02897-2024, and the document number for the request for confidential classification is 04360-2024.

DEF's response to POD No. 21 consists of sensitive business information about forecasted load profile data for General Service Demand and other customer types. DEF asserts that the data is proprietary, and public disclosure would impair it in the marketplace.

Staff has reviewed DEF's confidentiality request and agrees that the nature of the information meets the requirements set forth in Section 366.093(3)(e), F.S. Therefore, staff recommends that the request for confidentiality of certain information included in Document No. 02897-2024 be approved.
