Pursuant to Section 366.093(3)(e), Florida Statutes (F.S.) and Rule 25-22.006, Florida Administrative Code, Duke Energy Florida, LLC ("DEF") requests confidential classification of certain information provided in response to OPC's 2nd request for PODs (Nos. 27-28); specifically, response to POD No. 28, business information relating to both Duke Energy and third-party companies. The document number for the confidential filing is 02342-2024, and the document number for the request for confidential classification is 03012-2024.

DEF's response to POD No. 28 can be described as planning documents related to DEF's Infrastructure and Improvement Jobs Act Grant Prioritization Process. In its request for confidentiality, DEF asserts that disclosure of this information would harm DEF, as the information relates to security measures and competitive interests.

Staff has reviewed DEF's confidentiality request and agrees that the nature of the information meets the requirements set forth in Sections 366.093(3)(c), and 366.093(3)(e), F.S. Therefore, staff recommends that the request for confidentiality of certain information included in Document No. 02342-2024 be approved.
