## 1 P R O C E E D I N G S

2 CHAIRMAN LA ROSA: Items No. 16 through 18 we  
3 are going to take up also as a group. These are  
4 standard offer contracts, so I would ask staff to  
5 assemble these together, again, same procedure as  
6 previously. If there is discussion on one specific  
7 item that you would like to discuss or ask  
8 questions, obviously feel free during this segment.

9 As I allow staff to -- there is Mr. Sanchez  
10 right in front of me.

11 Mr. Sanchez, you are recognized for a summary.

12 MR. SANCHEZ: Good morning, Commissioners. My  
13 name is Segundo Sanchez with the Commission's  
14 engineering staff.

15 Items No. 16, 17 and 18 are petitions for  
16 approval of the 2024 amended standard offer  
17 contracts offered by Duke Energy Florida, Tampa  
18 Electric Company and Florida Power & Light Company  
19 respectively.

20 Florida Statutes require that each  
21 investor-owned utility continuously offer standard  
22 offer -- standard contracts for firm capacity and  
23 energy with provisions based on the utility's next  
24 avoidable fossil fuel generating unit.

25 Staff has reviewed the filings and believes

1           them to be consistent with each utility's next  
2           avoidable unit, and therefore, recommends approval  
3           of the amended standard offer contracts and  
4           associated rate schedules for each -- for all three  
5           items.

6           No comments were filed in any of the dockets.

7           CHAIRMAN LA ROSA: Thank you for that summary.

8           Commissioners, hearing a summary of the items,  
9           is there any questions or discussions? Questions  
10          or discussions?

11          COMMISSIONER CLARK: Move approval of the  
12          item, Mr. Chairman.


