## 1 P R O C E E D I N G S

2 CHAIRMAN LA ROSA: Let's move to Items No. 4  
3 through 13. This is where I was signifying we  
4 would hear this in a group.

5 And, of course, Commissioners, if there is any  
6 questions specifically on one of these items, I  
7 know a lot of them are the same, feel free to jump  
8 in, but we will go to staff for a summary.

9 MR. DAY: Good morning. I am Sam Day with the  
10 Office of Industry Development & Market Analysis.

11 Item Nos. 4 through 13 address petitions for  
12 designation as an eligible telecommunications  
13 carrier for the purpose of providing Lifeline  
14 service in Florida. Each of these petitions before  
15 you today were filed by wireless telecommunications  
16 providers.

17 As you are aware, since 2011, the Commission  
18 has been limited to only approving ETC petitions  
19 filed by wireline providers; however, recent  
20 legislation gave the Commission jurisdiction to  
21 grant ETC designation to wireless carriers for  
22 Lifeline purposes only. Staff has reviewed these  
23 petitions for compliance with federal and state ETC  
24 requirements.

25 If approved, staff believes that the

1 additional competition in the Lifeline market will  
2 provide Lifeline eligible consumers more choice in  
3 carriers, increase lifeline promotional activity  
4 and improve the overall lifeline subscribership  
5 rate in Florida.

6 CHAIRMAN LA ROSA: Hearing a summary,  
7 Commissioners, is there questions or discussions?  
8 Questions or discussions? This is Items 1 through  
9 13 -- I am sorry, 4 through 13. I misspoke  
10 earlier, so 4 through 13.

11 COMMISSIONER CLARK: Move approval of the  
12 item, Mr. Chairman.

13 COMMISSIONER GRAHAM: Second.  
14 All those in favor, signify by saying yay.  
15 (Chorus of yays.)

16 CHAIRMAN LA ROSA: Yay.  
17 Opposed no.

18 (No response.)

19 CHAIRMAN LA ROSA: Show that Items 4 through  
20 13 pass.


