Pursuant to Sections 366.093(3)(c) and 366.093(3)(d), and 366.093(e), Florida Statutes (F.S.) and Rule 25-22.006, Florida Administrative Code, Duke Energy Florida, LLC ("DEF") requests confidential classification of certain information and documents provided in response to LULAC and FL Rising's 5th request for PODs (Nos. 39-43). The document number for the confidential filing is 04491-2024, and the document number for the request for confidential classification is 06728-2024.

DEF's response to LULAC and FL Rising's 5th request for POD Nos. 41 and 42 contains pricing and other terms and conditions of contacts DEF entered into. In addition, certain documents in the response to POD No. 42 contain details about the location and nature of future transmission planning projects. In its request for confidential classification, DEF asserts that disclosure of this information would impair DEF's ability to compete in the marketplace.

Staff has reviewed DEF's confidentiality request and agrees that the nature of the information meets the requirements set forth in Sections 366.093(3)(c), 366.093(3)(d) and 366.093(3)(e), F.S. Therefore, staff recommends that the request for confidentiality of certain information included in Document No. 04491-2024 be approved.
