Pursuant to Section 366.093, Florida Statues (F.S.), and Rule 25-22.006, Florida Administrative Code, Duke Energy Florida, LLC (Duke or Company) requests confidential classification of certain information filed in the above-referenced docket, dated May 9, 2024. The subject information related to this request is in response to The Office of Public Counsel's (OPC) Sixth Set of Interrogatories.

The Company is claiming confidentiality of its filing under Section 366.093(3)(c), and F.S. 366.093(3)(e), F.S.
