Pursuant to Section 366.093(e), Florida Statutes (F.S.) and Rule 25-22.006, Florida Administrative Code, Duke Energy Florida, LLC ("DEF") requests confidential classification of certain information provided in response to OPC's 9th set of interrogatories (Nos. 222-244), specifically, responses to interrogatory Nos. 243 and 244. The document number for the confidential filing is 03910-2024, and the document number for the request for confidential classification is 04566-2024.

DEF's response to staff interrogatory Nos. 243 and 244 contains cost-related estimates for transmission and distribution upgrade projects. In its request for confidential classification, DEF asserts that disclosure of this information would impair DEF's ability to compete in the marketplace.

Staff has reviewed DEF's confidentiality request and agrees that the nature of the information meets the requirements set forth in Section 366.093(3)(e), F.S. Therefore, staff recommends that the request for confidentiality of certain information included in Document No. 03910-2024 be approved.
