Pursuant to Sections 366.093(3)(c) and 366.093(3)(d), and 366.093(e), Florida Statutes (F.S.) and Rule 25-22.006, Florida Administrative Code, Duke Energy Florida, LLC ("DEF") requests confidential classification of certain information provided in response to staff's 6th set of interrogatories (Nos. 55-73). The document number for the confidential filing is 06477-2024, and the document number for the request for confidential classification is 07270-2024.

DEF's response to staff interrogatory No. 60 contains labor and other cost-related estimates for distribution projects. DEF's response to interrogatory Nos. 61 and 65 contains pricing and other related information for bids the utility evaluated for battery storage and solar projects. DEF's response to interrogatory No. 67 contains details about the utility's asset optimization strategy as well as actual and projected savings from the program. In its request for confidential classification, DEF asserts that disclosure of this information would impair DEF's ability to compete in the marketplace.

Staff has reviewed DEF's confidentiality request and agrees that the nature of the information meets the requirements set forth in Sections 366.093(3)(c), 366.093(3)(d) and 366.093(3)(e), F.S. Therefore, staff recommends that the request for confidentiality of certain information included in Document No. 06477-2024 be approved.
