On May 13, 2024, Duke Energy Florida (DEF or Company) filed a request for confidential treatment of Document No. 02988-2024. This document contains confidential information from a response to FIPUG's First Request for Production of Documents, No 1. The confidential information contained within the response can be described as financial reports containing pricing information and DEF's regulatory and strategic plans related to interruptible and curtailable credit programs.

In its request for confidentiality, DEF asserts that disclosure of this information would harm DEF, as the information relates to confidential procedures and competitive interests. Furthermore, DEF states that the Company treats the highlighted information provided in Document No. 02988-2024 as private and has not publicly disclosed it.

Staff has reviewed the documents and concurs with DEF that the nature of the information meets the requirements set forth in Section 366.093(3)(e), Florida Statutes, whereby disclosure of the information would impair DEF's competitive business interests. Therefore, staff recommends the request by DEF for confidential classification of Document No. 02988-2024 be approved.
