On May 20, 2024, JEA (or Company) filed a request for confidential treatment of Document No. 03362-2024. This document contains confidential information from a response to Staff's First Request for Production of Documents, No 1. The confidential information contained within the response can be described as demand response analysis and results that are proprietary to Resource Innovations, who performed the analysis.

In its request for confidentiality, JEA asserts that disclosure of this information would harm Resource Innovations, as the information relates to trade secrets and competitive interests. Furthermore, JEA states that the Company treats the highlighted information provided in Document No. 03362-2024 as private and has not publicly disclosed it.

Staff has reviewed the documents and concurs with JEA that the nature of the information meets the requirements set forth in Section 366.093(3)(e), Florida Statutes, whereby disclosure of the information would impair JEA's competitive business interests. Therefore, staff recommends the request by JEA for confidential classification of Document No. 03362-2024 be approved.
