Transmitted herewith for your review and approval is revised Miscellaneous Charges Tariff Sheet No. 4.1 for Talquin Electric Cooperative, Inc. (the "Cooperative").

The existing tariff sheet is revised to:

- Reduce the residential deposit from \$525 to \$400, and
- Increase the deposit for a new home under construction from \$250 to \$400.

The reason for implementing the residential deposit revision is to better reflect a dollar amount equal to two times the average monthly billing for residential services. The reason for the revision to the new home under construction deposit is to make it the same as the revised deposit for existing residential services.
