On May 30, 2024, Duke Energy Florida, LLC (DEF or Company) filed a request for confidential treatment of Document No. 04493-2024. This document contains confidential information from a response to Sierra Club's fifth set of interrogatories (Nos. 98-109). The confidential information contained within the response can be described as transmission system information and generating unit constraints data for all facilities including Crystal River Units 4 & 5 for the period May 1, 2024, through May 8, 2024.

In its request for confidentiality, DEF asserts that disclosure of this information would harm DEF, as the information relates to proprietary confidential business information concerning its transmission system and generating facilities. If disclosed, the transmission system information could be a security risk to DEF, its customers, and the grid. In addition, the information relating to DEF's generation units would impair their ability to compete in the marketplace.

Staff has reviewed the document and concurs with DEF that the nature of the information meets the requirements set forth in Section 366.093(3)(c) and (e), Florida Statutes, whereby disclosure of the information could represent a security risks to the Company and would impair their ability to compete in the marketplace. Therefore, staff recommends the request by DEF for confidential classification of Document No. 04493-2024 be approved.
