On June 13, 2024, Tampa Electric Company (TECO or Company) filed a request for confidential treatment of Document No. 06370-2024. This document contains confidential information from a response to Staff's Fifth Set of Interrogatories, No. 67. The confidential information contained within the response can be described as transmission interconnection location information and transmission contingency plans.

In its request for confidentiality, TECO asserts that disclosure of this information would harm TECO, as the information relates to security systems and competitive interests. Furthermore, TECO states that the Company treats the highlighted information provided in Document No. 06370-2024 as private and has not publicly disclosed it.

Staff has reviewed the documents and concurs with TECO that the nature of the information meets the requirements set forth in Section 366.093(3)(c) and (e), Florida Statutes, whereby disclosure of the information would disclose security systems and impair the competitive business interests. Therefore, staff recommends the request by TECO for confidential classification of Document No. 06370-2024 be approved.
