Clerk of the Public Service Commission:

My wife Debra and I are writing to express our objections and concerns about the public sewer project that has been proposed for Palm Island. After visiting the island each year for more than thirty years we became homeowners this past June 7th. With delight, we acquired the property at 301 S. Gulf Blvd., #421 in the Don Pedro Colony. Our adult special needs son, Nathan, lives with us and loves the island. He has accompanied us on every trip we have made.

We are concerned that the company proposing the sewer development project is a private, for-profit, company that will be committed first to making a profit for its shareholders and not the preservation of the natural beauty of the island which brings us there. Adding to this concern is the fact that we are not aware of

significant prior experience by the development company in the business of owning, building and operating an island sewer system. We are not aware of any studies indicating a pressing need for a new sewer system at this time and none of our local neighbors and contacts have mentioned that they had requested a sewer system. When we add the concern about the heavy costs that we will be forced to bear to build and operate the new system. We must object to this project at this time.

Please do not allow this sewer project to proceed at this time.
