On July 22, 2024, Tampa Electric Company (TECO or Company) filed a request for confidential treatment of Document No. 07738-2024. This document contains confidential information contained in the exhibit of TECO witness, John C. Heisey, as informally requested by Office of Public Counsel for use in witness Heisey's deposition. The confidential information contained within the response can be described as 2023 sales and gains amounts for TECO's Asset Optimization program.

In its request for confidentiality, TECO asserts that disclosure of this information would harm TECO, as the information relates to contractual data and competitive interests. Furthermore, TECO states that the Company treats the highlighted information provided in Document No. 07738-2024 as private and has not publicly disclosed it.

Staff has reviewed the documents and concurs with TECO that the nature of the information meets the requirements set forth in Section 366.093(3)(d) and (e), Florida Statutes, whereby disclosure of the information would disclose contractual data and impair the competitive business interests. Therefore, staff recommends the request by TECO for confidential classification of Document No. 07738-2024 be approved.
