Pursuant to Sections 366.093(d), and 366.093(3)(e), Florida Statutes (F.S.) and Rule 25-22.006, Florida Administrative Code, Duke Energy Florida, LLC ("DEF") requests confidential classification of certain information provided in DEF's response to OPC's 13th set of interrogatories (Nos. 334-338) and 13th request for PODs (Nos. 142-145); specifically, responses to interrogatory No. 338 and POD No. 145. The confidential filing is 04546-2024, and the document number for the request for confidential classification is 07801-2024.

DEF's response to interrogatory No. 338 and POD No. 145 contain detailed information about the costs, locations, and other information about storage and transmission projects. DEF asserts that disclosure of this information could pose security risks, as well as impair DEF's ability to compete in the marketplace.

Staff has reviewed DEF's confidentiality request and agrees that the nature of the information meets the requirements set forth in Sections 366.093(d), and 366.093(3)(e), F.S. Therefore, staff recommends that the request for confidentiality of certain information included in Document No. 04546-2024 be approved.
