On July 30, 2024, Tampa Electric Company (TECO or Company) filed a request for confidential treatment of Document No. 08077-2024. This document contains confidential information contained in the late-filed deposition Exhibit 2 to the deposition transcript of witness Archie Collins. The confidential information contained within the document can be described as a presentation on how TECO addresses affordability.

In its request for confidentiality, TECO asserts that disclosure of this information would harm TECO, as the information relates to competitive interests. Furthermore, TECO states that the Company treats the highlighted information provided in Document No. 08077-2024 as private and has not publicly disclosed it.

Staff has reviewed the document and concurs with TECO that the nature of the information meets the requirements set forth in Section 366.093(3)(e), Florida Statutes, whereby disclosure of the information would impair the competitive business interests. Therefore, staff recommends the request by TECO for confidential classification of Document No. 08077-2024 be approved.
