Pursuant to Section 366.093 of the Florida Statutes (F.S), and Rule 25-22.006, Florida Administrative Code, Tampa Electric Company, Inc. (TECO or Company) requests confidential classification of highlighted information that was provided on May 23, 2024, in response to Staff's First Request for Production of Documents (PODs), Nos. 1 – 15, specifically POD No. 5, issued in the above docket, which relates to TECO's phosphate customers and usage.

TECO is claiming confidentiality of certain information contained in its response to Staff's First Request for PODs, Nos. 1 - 15, specifically POD No. 5, under Section 366.093(3)(d) and (e), F.S. Per the statute, propriety of confidential business information includes, but is not limited to: Subsection (d) "[i]nformation concerning bids or other contractual data, the disclosure of which would impair the efforts of the public utility or its affiliates to contract for goods or services on favorable terms," and Subsection (e) "[i]nformation relating to competitive interests, the disclosure of which would impair the competitive business of the provider of the information." The Company maintains that the information provided in the aforementioned response for which confidential treatment is being requested contains competitive business information as well as information concerning bids or other sensitive contractual data.

Staff has reviewed the information provided in TECO's response to Staff's First Request for PODs, Nos. 1 - 15, specifically POD No. 5, as well as the Company's confidentiality request. In staff's opinion, the information that is the subject of the confidentiality request does meet the criteria for confidentiality contained in Section 366.093 F.S. Therefore, staff recommends that the request for confidentiality of certain information included in Document No. 03895-2024 be approved.
