10	On May 5th, 2024, Peoples and FPUC filed a
11	joint petition for approval of a special contract
12	for firm gas transportation service commencing on
13	September 1st, 2024. The parties had a similar
14	2022 special contract, which was approved by the
15	Commission, and expired on June 1st, 2024. At that
16	time, the gas transportation service ceased.
17	Pursuant to the proposed contract, the receipt
18	point, deliver points and points of delivery are
19	the same as in the 2022 special contract. Under
20	the terms of this proposed contract, Peoples would
21	provide FPUC with firm gas transportation service,
22	allowing the delivery of natural gas in Nassau
23	County for an additional seven-month term, ending
24	on April 1st, 2025.
25	Staff has reviewed the proposed special
