Patrick Kelley with the Division of Economics.

Item 7 is a petition by Peoples Gas System and Florida Public Utilities Company for approval of a special contract.

On May 5th, 2024, Peoples and FPUC filed a joint petition for approval of a special contract for firm gas transportation service commencing on September 1st, 2024. The parties had a similar 2022 special contract, which was approved by the Commission, and expired on June 1st, 2024. At that time, the gas transportation service ceased.

Pursuant to the proposed contract, the receipt point, deliver points and points of delivery are the same as in the 2022 special contract. Under the terms of this proposed contract, Peoples would provide FPUC with firm gas transportation service, allowing the delivery of natural gas in Nassau County for an additional seven-month term, ending on April 1st, 2025.

Staff has reviewed the proposed special

1 contract and believes that it is reasonable.
2 Therefore, staff recommends that the Commission
3 should approve the proposed special contract.


