On August 21, 2024, Tampa Electric Company (TECO or Company) filed a request for confidential treatment of Document No. 08565-2024. This document contains confidential portions of the July 26, 2024 deposition transcript of witness Archie Collins. The confidential information contained within the document is the approximate percentage of a community in Hillsborough County that is experiencing energy poverty.

In its request for confidentiality, TECO asserts that disclosure of this information would harm TECO, as the information relates to competitive interests. Furthermore, TECO states that the Company treats the highlighted information provided in Document No. 08565-2024 as private and has not publicly disclosed it.

Staff has reviewed the document and concurs with TECO that the nature of the information meets the requirements set forth in Section 366.093(3)(e), Florida Statutes, whereby disclosure of the information would impair the competitive business of the provider of the information. Therefore, staff recommends the request by TECO for confidential classification of Document No. 08565-2024 be approved.
