Staff has reviewed CSWR-Florida Utility Operating Company's (CSWR or Utility) application for a grandfather certificate to operate a water and wastewater utility in Citrus County. After reviewing this information, we find the application to be deficient. The specific deficiencies are identified as:

- 1. **System Map**: Rule 25-30.035(14), Florida Administrative Code (F.A.C.), requires a detailed system map showing the existing and proposed lines and treatment facilities, with the territory proposed to be served plotted thereon, consistent with the legal description provided. It does not appear that the system map provided with the Utility's application shows the existing or proposed lines. Please provide a system map(s) to meet this requirement.
- 2. **Permits**: Rule 25-30.035(16), F.A.C., requires a copy of all current permits issued by the Department of Environmental Protection (DEP) and water management district. The application states it is for water and wastewater services; however, the DEP water permit was not included in the application. Please provide the water permit to meet the requirement.
