4. <u>STATEMENT OF ISSUES AND POSITIONS</u>

GENERIC ENVIRONMENTAL COST RECOVERY ISSUES

- **<u>ISSUE 1</u>**: What are the final environmental cost recovery true-up amounts for the period January 2023 through December 2023?
 - **FPL:** \$7,623,275 over-recovery. (Hume, MacGregor)
- **<u>ISSUE 2</u>**: What are the estimated/actual environmental cost recovery true-up amounts for the period January 2024 through December 2024?
 - **FPL:** \$18,176,707 under-recovery. (Hume, MacGregor)
- **<u>ISSUE 3</u>**: What are the projected environmental cost recovery amounts for the period January 2025 through December 2025?
 - **FPL:** \$401,635,933. (Hume, MacGregor)
- **<u>ISSUE 4</u>**: What are the environmental cost recovery amounts, including true-up amounts, for the period January 2025 through December 2025?
 - **FPL:** \$412,189,365. (Hume, MacGregor)

- **<u>ISSUE 5</u>**: What depreciation rates should be used to develop the depreciation expense included in the total environmental cost recovery amounts for the period January 2025 through December 2025?
 - **FPL:** The depreciation rates used to calculate the depreciation expense should be the rates that are in effect during the period the allowed capital investment is in service. For the period January 2025 through December 2025, FPL will use the depreciation rates that were approved by the Commission in Order No. PSC-2021-0446-S-EI. (Hume)
