5	This is Kate McClelland with the Division of
6	Economics.
7	Item No. 5 is a petition by Florida Public
8	Utilities Company to implement swing service rider
9	rates for January through December 2025.
10	The swing service rider allocates a portion of
11	the company's intrastate natural gas pipeline
12	capacity costs to transportation customers. The
13	proposed swing service rider includes intrastate
14	pipeline capacity costs, gas supply software fees,
15	market data fees and legal fees. The swing service
16	rider is a cents per therm charge that is
17	calculated and included in the monthly bill for
18	transportation customers.
19	Staff has reviewed the proposed rates and
20	believes that they have been calculated according
21	to the original order approving a swing service
22	tariff. Staff recommends that the Commission
23	should approve FPUC's proposed swing service rider
24	rates to be effective for the period January
25	through December 2025.
