# PRELIMINARY ORDER 00-13 CITRUS COUNTY WATER AND WASTEWATER AUTHORITY

A PRELIMINARY ORDER OF THE CITRUS COUNTY WATER AND WASTEWATER AUTHORITY, PURSUANT TO SECTION 1-2 (P)(2)(b) AND SECTION 1-4 (D) OF CITRUS COUNTY ORDINANCE NO. 99-07, RECOMMENDING THAT THE BOARD OF COUNTY COMMISSIONERS GRANT INDIAN SPRINGS UTILITIES CERTIFICATE FOR THE PROVISION OF WASTEWATER SERVICE IN SPECIFIC AREAS OF CITRUS COUNTY CONSISTENT WITH THE CERTIFICATES PREVIOUSLY ISSUED BY THE FLORIDA PUBLIC SERVICE COMMISSION.

WHEREAS, Resolution No. 99-111 excluded Citrus County from the provisions of Chapter 367, Florida Statutes, thereby assuming certain subject matter jurisdiction over non-exempt water and/or wastewater utilities operating in Citrus County; and

WHEREAS, Ordinance No. 99-07 established the Citrus County Water and Wastewater Authority (AUTHORITY) and specific powers and duties; and

WHEREAS, Indian Springs Utilities (UTILITY) has submitted its application for Grandfather Certificate for the continued provision of wastewater service; and

WHEREAS, the AUTHORITY has determined that the UTILITY'S application satisfies all applicable requirements of Ordinance No. 99-07; and

WHEREAS, only the Citrus County Board of County Commissioners (BOARD) may issue a Franchise Certificate to any utility; and

WHEREAS, on June 6, 2000 the AUTHORITY adopted Preliminary Order No. 00-07 in error recommending to the Board of County Commissioners that they enact a Final Order to grant Grandfather Certificate No. 07W for water service; and

WHEREAS, on June 13, 2000 the Board of County Commissioners did enact Resolution 2000-094 to grant Indian Springs Utilities, Inc. Certificate No. 07W for water service.

THIS PRELIMINARY ORDER IS THEREFORE ISSUED by the AUTHORITY, in public meeting assembled, that:

- 1. The AUTHORITY hereby recommends that the BOARD issue Grandfather Certificate to the UTILITY for the provision of wastewater service for the service areas described in the application.
- 2. The AUTHORITY hereby rescinds Preliminary Order No. 00-07.
- 3. The AUTHORITY also hereby recommends that the Board rescind Grandfather Certificate No. 07W issued in Resolution No. 2000-094.
- 4. This action contemplates no change in the UTILITY'S rate tariffs or service areas previously approved by the Florida Public Service Commission.

#### RESOLUTION NO. 2000-154

A RESOLUTION OF CITRUS COUNTY, FLORIDA, PURSUANT TO SECTION 1-4(E), CITRUS COUNTY ORDINANCE NO. 99-07, GRANTING INDIAN SPRINGS UTILITIES, INC. GRANDFATHER CERTIFICATE FOR THE PROVISION OF WASTEWATER SERVICE IN SPECIFIC AREAS OF CITRUS COUNTY CONSISTENT WITH THE CERTIFICATE PREVIOUSLY ISSUED BY THE FLORIDA PUBLIC SERVICE COMMISSION.

WHEREAS, Resolution No. 99-111, adopted July 27, 1999, excluded Citrus County from the provisions of Chapter 367, Florida Statutes, thereby assuming certain subject matter jurisdiction over non-exempt water and wastewater utilities operating in specific areas of Citrus County; and

WHEREAS, Ordinance No. 99-07, adopted August 24, 1999, established the Citrus County Water and Wastewater Authority (AUTHORITY) and specific powers and duties; and

WHEREAS, Ordinance No. 99-07 requires that each non-exempt water and wastewater utility operating in Citrus County must apply for Grandfather Certificates from Citrus County; and

WHEREAS, Indian Springs Utilities, Inc. (UTILITY) has submitted its application for Grandfather Certificates for the continued provision of wastewater service; and

WHEREAS, on August 7, 2000, the AUTHORITY considered UTILITY'S application and issued its Preliminary Order No. 00-13, recommending that the Board of County Commissioners of Citrus County (BOARD) grant UTILITY Grandfather Certificate to provide wastewater service in specific areas of the County at the same rates identified in the application, consistent with the service areas and rates previously approved by the Florida Public Service Commission; and

WHEREAS, on June 6, 2000 the AUTHORITY in error issued Preliminary Order No. 00-07 to recommend to the BOARD that they issue a Grandfather Certificate for water service; and

WHEREAS, on June 13, 2000 the BOARD in Resolution No. 2000-094 did formally approve the issuance of Grandfather Certificate No. 07W for water service by Indian Springs Utilities, Inc.; and

WHEREAS, pursuant to Ordinance No. 99-07, only the BOARD may issue or revoke Certificates to a utility operating in the County.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of Citrus County, Florida, that:

- 1. Pursuant to Section 1-4(E), Ordinance No. 99-07, Certificate No. "04S" for wastewater is hereby issued to UTILITY for the continued provision of wastewater service for the specific service areas identified in UTILITY'S Application for Grandfather Certificates.
- 2. A duplicate original of Certificate No. "04S" is attached hereto as "Attachment A".
- 3. Certificate No. "04S" shall remain in force and effect until suspended, canceled or revoked by Resolution of the BOARD.
- 4. Certificate No. "07W" for water service is hereby revoked.
- 5. This action contemplates no change in UTILITY'S rate tariffs or service areas previously approved by the Florida Public Service Commission.





Dear Indian Springs Utilities Customer:

Welcome to our family. If you have any questions or comments you may reach Gabby, our bookkeeper, or myself at the above number. Our billing guidelines established by the Florida Public Service Commission are as follows:

#### Pursuant to Rule 25-30.320, Florida Administrative Code:

Bills are due and payable when rendered and become delinquent if not paid within sixteen (16) days after date of invoice (twenty one days for customers residing outside of Florida). Written notice of the delinquency is mailed to the customer separate and apart from any other bill, and after five (5) working days service may then be discontinued.

A utility may refuse or discontinue service for nonpayment of bills for utility service by the same or an affiliated utility after the customers are provided notice.

If service is physically disconnected for any reason, the utility must notify the City of Crystal River and the County Health Department.

#### Pursuant to Rule 25-30.311 (7) Florida Administrative Code:

The Company may require a new deposit, where previously waived or returned, or an additional deposit in order to secure payment of current bills provided. The Company shall provide the customer with reasonable written notice of not less than 30 days were such request or notice is separate and apart from any bill for service. The total amount of the required deposit shall not exceed an amount of equal to the average actual charge of wastewater serviced for two monthly billing periods for the 12 month period immediately prior to the date of notice. In the event the customer has service less than 12 months, the Company shall base its new or additional deposit upon the average actual monthly billing available.

**REFUND OF DEPOSIT**: After a residential customer has established a satisfactory payment record and has had continuous service for a period of 23 months, the Company shall refund the customer's deposit provided the customer has NOT, the preceding 12 months: A) made more than one late payment of the bill (after the expiration of 20 days from the date of mailing or delivery by the Company), B) paid with a check refused by a bank, C) been disconnected for nonpayment, or D) at any time tampered with the meter or used service in a fraudulent or unauthorized manner.
