2 CHAIRMAN LA ROSA: Let's now move to Item No.

3 6.

4 Mr. Ward, you are recognized for a summary.

5 MR. WARD: Good morning, Commissioners.

6 Oakley Ward with the Division of Economics.

7 Item 6 is a petition by Peoples Gas System,  
8 Inc., for approval of the 2023 true-up, projected  
9 2024 true-up, and 2025 revenue requirements and  
10 surcharges associated with the cast iron/bare steel  
11 pipe replacement rider.

12 Peoples was originally scheduled to complete  
13 the cast iron/bare steel pipe replacement in 2022,  
14 but it explained that it experienced delays.

15 Peoples stated that it expects to have  
16 approximately 8.11 miles of cast iron/bare steel  
17 replacement remaining entering 2025. The  
18 replacement of problematic plastic pipeline is  
19 expected to continue until 2028. The proposed  
20 surcharge would have a monthly bill impact of 28  
21 cents for a residential customer who uses 20  
22 therms.

23 Staff recommends approval of the proposed  
24 surcharges.

25 CHAIRMAN LA ROSA: Thank you for the summary.

4           COMMISSIONER CLARK: Move to approve, Mr.  
5           Chairman.


