1 PROCEEDINGS 2 We are going to move CHAIRMAN LA ROSA: 3 through Items 5 through 8. We are going to hear 4 these in a block. Is that all right, Mr. Sanchez, 5 you can over these as a summary in a block? 6 MR. SANCHEZ: That's fine. 7 CHAIRMAN LA ROSA: Yeah, so let's go ahead and 8 do that. So Items 5 through 7, you are recognized, sir. 9 10 All right. MR. SANCHEZ: Items Nos. 5 through 11 8 are petitions for approval of the 2025 amended 12 standard offer contracts by Tampa Electric Company, 13 Duke Energy Florida, Florida Public Utilities 14 Company and Florida Power & Light Company 15 respectively. 16 Florida Statutes require that each 17 investor-owned utility continuously offer standard 18 contracts for firm capacity and energy with 19 provisions based on the utility's next avoidable 20 fossil fuel generating unit. 21 Staff has reviewed the filings and believes 2.2 them to be consistent with each utility's next 23 avoidable unit, and, therefore, recommends approval 24 of the amended standard offer contracts and 25 associated rate schedules for all four items.

1 For Item No. 7 specifically, FPUC is also 2 seeking a rule waiver for the annual filing 3 requirement until a change occurs in their 4 purchased power agreements. 5 Staff also recommends approval of this rule waiver. 6 7 No comments were filed in any of the dockets, 8 and staff is available for any questions. 9 CHAIRMAN LA ROSA: Great. Thank you. 10 And just for clarification, 5 through 8 in 11 case I may have said something different. 12 Commissioners, are there any questions or 13 discussions on Items 5 through 8? 14 Seeing none, open for a motion. 15 Move to approve, Mr. COMMISSIONER CLARK: 16 Chairman. 17 COMMISSIONER GRAHAM: Second. 18 Hearing a motion and CHAIRMAN LA ROSA: 19 hearing a second on Items 5 through 8. 20 All those in favor signify by saying yay. 21 (Chorus of yays.) 2.2 CHAIRMAN LA ROSA: Yay. 23 Opposed no? 24 (No response.) 25 CHAIRMAN LA ROSA: Show that those items pass.
